WHEREAS, the Municipality of Loon through its Bids and Awards Committee (BAC), undertook Alternative Mode of Procurement - Negotiated Procurement through Emergency Cases for the project **MEALS FOR LOCALLY STRANDED INDIVIDUALS & OFWs IN MOTO SUR COVERED COURT** for the period September 16, 2020 to October 7, 2020 with an approved budget for the contract amounting to **One Hundred Thousand One Hundred Ten Pesos (₱ 100,110.00)**;

WHEREAS, a Request for Quotation (RFQ) was sent by the end-user unit to the suppliers with technical, legal and financial capability to deliver the goods requested to address the emergency;

WHEREAS, price quotations were submitted by: 1) Platterz Food and Catering Services; 2) Mary Jean Restaurant; 3) Emper's Carenderia, and were evaluated as follows:



WHEREAS, the quotation of **PLATTERZ FOOD AND CATERING SERVICES** was considered as the lowest calculated bid and was substantially complying;






