



INVITATION TO BID FOR THE PURCHASE & INSTALLATION OF REMOTE SENSING EQUIPMENT FOR PUMPING STATIONS & STRATEGIC PIPE SECTIONS

1. The Local Government Unit of Loon, Bohol through its appropriation from the development fund intends to apply the sum of **One Million Five Hundred Thousand Pesos (P 1,500,000.00)**, being the Approved Budget for the Contract [ABC], to payment under the contract for the **Purchase & Installation of Remote Sensing Equipment For Pumping Stations & Strategic Pipe Sections** following by way of Competitive Bidding of Republic Act No, 9184, otherwise known as the "Government Procurement Reform Act" [IRR/RA No. 9184].

2.0 The Local Government Unit of Loon, Bohol now invites bids for the project below:

3.0 Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4.0 Interested bidders may obtain further information from Office of the Bids and Awards Committee [BAC], through the BAC Secretariat, Municipal Hall, Loon, Bohol and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday.

5.0 A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P 5,000.00**.


6.0 In addition to Class "A" and Class "B" Eligibility Criteria of IRR/RA No. 9184, Bidders should have completed within **3 years** from the date of submission and receipt of bids, a contract at least one similar project. The description of an eligible bidder is contained in the Bidding Documents particularly, in Section II, Instruction to Bidders.

7.0 Bids must be delivered to the address on or before **July 31, 2023, at 8:30 AM** at the Office of the Bids and Awards Committee, Municipal Hall, Cogon Norte, Loon, Bohol. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids will not be accepted.
