MUNICIPAL ORDINANCE NO. 00-007
Series of 2000

AN ORDINANCE ABOLISHING AND CREATING CERTAIN POSITIONS IN THE 2000 PLANTILLA OF PERSONNEL OF THE MUNICIPAL GOVERNMENT OF LOON, BOHOL

Be it ordained by the Seventh Sangguniang Bayan of Loon, Bohol in session duly assembled, that:

Section 1. Abolition of Positions – The following positions in the 2000 Plantilla of Personnel of the Municipal Government of Loon, Bohol, are hereby abolished, viz:

- (1) One (1) Information Officer II - SG-15
- (2) One (1) Day Care Worker I - SG-6
- (3) One (1) Legislative Staff Officer I - SG-11
- (4) One (1) Librarian I - SG-10

Section 2. Creation of Position – The following positions in the 2000 Plantilla of Personnel of the Municipal Government of Loon, Bohol, are hereby created, viz:

- (1) One (1) Social Welfare Officer IV - SG-22
- (2) Two (2) Utility Worker I - SG-1
- (3) One (1) Clerk IV - SG-8

Section 3. Rationale – The abolition and creation of the aforementioned positions in the 2000 Plantilla of Personnel is in line with the thrust of the Municipal Government.

Section 4. Sponsorship and Deliberation – This ordinance was introduced by Honorable Vice Mayor Raul P. Barbarona and sponsored by Honorable Buenaventura Orcullo, Chairperson of the Committee on Good Government, Public Ethics and Accountability, and Honorable Clovis Nazareno and Honorable Zenon Perez, Committee Members.

Section 5. Effectivity – This ordinance shall take effect upon its approval.
