INTRODUCTORY BRIEF

The Local Government Unit of Loon, Province of Bohol, envisions a peaceful town whose economic growth is anchored on agriculture, trading, ecotourism and people empowerment through shared and service-oriented governance.

In realizing its vision the LGU of Loon makes every effort to create a tourist and business-friendly environment by sustainably managing the town's resources and heritage while promoting peace, health and prosperity.

The devastating 7.2-magnitude earthquake that shook Bohol and neighboring provinces on October 15, 2013 resulted in, among others, the uplift of a portion of the intertidal zone within the municipal waters of Loon, from Song-on on the South up to Canhangdon Occidental on the north with an area of 417 hectares.

For various reasons, the uplifted coastal zone has become an object of interest of the local and national governments, community members, the academe, scientists, land-use planners, and private individuals.

There is a need to protect the geological and ecological site and enhance the public's awareness of its scientific and socio-cultural significance.

Being an unexpected addition to the mainland of Loon and only through which access to the municipal waters is possible, it is of utmost concern for the LGU to develop the area for what it is most suited with due consideration to environmental protection and conservations; development of sustainable livelihood; promotion of cultural heritage; and enhancement of people's creativity.

AN ORDINANCE ESTABLISHING THE COASTAL GEOMORPHIC CONSERVATION AND TOURISM PARK OF THE UPLIFTED INTERTIDAL ZONE OF THE MUNICIPALITY OF LOON, PROVINCE OF BOHOL, OTHERWISE KNOWN AS "THE LUIZ ORDINANCE", AMENDING FOR THIS PURPOSE MUNICIPAL ORDINANCE NO. 14-003, SERIES OF 20014

Be it enacted by the 14th Sangguniang Bayan of Loon, Bohol in session duly assembled:

- **SECTION 1. ESTABLISHMENT OF THE COASTAL GEOMORPHIC CONSERVATION AND TOURISM PARK.** There shall be established a Coastal Geomorphic Conservation and Tourism Park at the uplifted intertidal zone of the Municipality of Loon, Province of Bohol.
- **SECTION 2. DEFINITION OF TERMS.** The following terms, as mentioned in this ordinance, are hereby defined:
- 2.a. Intertidal Zone also known as foreshore and seashore and sometimes referred to as the littoral zone, is the area that is above water at low tide and under water at high tide. In other words, it is the area between low tide and high tide marks
- 2.b. Geomorphic relating to the form of the landscape and other natural features of the earth's surface
- 2.c. Mangrove areas a forest or dense thicket of tropical evergreen trees or shrubs having stilt-like intertwining aerial or prop roots that grow below the highest tide levels in swampy areas
- 2.d. Highest high tide the tide at its fullest, when the water reaches its highest level at a certain time of the year

SECTION 3. DETERMINATION OF BOUNDARIES AND TOTAL AREA.

- 3.1) The boundaries of the Loon Coastal Geomorphic Conservation Park shall consist of the following:
 - 3.a. Loon-Maribojoc municipal boundary following a straight line from the mainland boundary to the municipal waters boundary;
 - 3.b. Canhangdon Occidental-Sandingan Island boundary; and
 - 3.c. Landward to seaward, from the pre-earthquake original shoreline including the mangrove areas up to twenty (20) meters from the sea water's edge taken during the highest high tide.
- 3.2) The official Department of Environment and Natural Resources (DENR) survey defining the boundaries and areas of the Loon Coastal Geomorphic Conservation and Tourism Park shall be adopted, as reflected in Tables 1,2, and 4,Lot Description Survey No. SK-07-00180 (Date Surveyed: March 6-7, 2014), viz:

SECTION 4. DRAFTING OF LOON COASTAL GEOMORPHIC CONSERVATION PARK DEVELOPMENT MASTER PLAN. The Local Government Unit of Loon shall draft a master plan

for the development and conservation of the uplifted intertidal zone subject to the approval of the Sangguniang Bayan. The plan may include, but not limited to, the following major components:

- 4. a. Construction of a southern coastal road with support infrastructure;
- 4.b. Establishment of areas for amusement, recreation, sports and other physical activities:
- 4.c. Development of tourism products that involve nature and heritage appreciation and conservation, as well as sports and extreme adventure;
- 4.d. Construction of strategic infrastructure for tourism-related activities;
- 4.e. Enhancement of the existing fish sanctuaries and development of other fisheryrelated projects; and
- 4.f. The Loon Coastal Geomorphic Conservation Park Development Plan (LCGCPDP) formulated by the Tourism Infrastructure and Enterprise Zone Authority (TIEZA) shall be adopted, provided that its implementation does not involve any or all of the prohibited acts described in Section 12, hereof. (new amendment)

SECTION 5. RESEARCH AND DEVELOPMENT. In order to generate relevant information on the uplifted intertidal zone, the Local Government Unit, in coordination with educational and scientific institutions and organizations, shall conduct research and launch activities that promote widespread dissemination of the generated information and encourage the protection and conservation of the park's natural resources.

SECTION 6. CREATION OF LOON COASTAL GEOMORPHIC CONSERVATION AND TOURISM PARK MANAGEMENT COUNCIL. There shall be created a management council known as Loon Coastal Geomorphic Conservation Park Management Council to be composed of the following:

SECTION 7. *TECHNICAL WORKING GROUP (TWG).* There shall be created a Technical Working Group (TWG) to be composed of the following:

TWG Chief. The Municipal Planning and Development Coordinator TWG Members:

- 1. MENRO
 - 2. Tourism Officer
 - 3. Cultural Heritage Officer
 - 4. Municipal Agriculturist
 - 5. Municipal Assessor
 - 6. Municipal Legal Consultant
 - 7. Municipal Engineer

TWG Consultants:

- 1. For property planning and estate development
- 2. For tourism development and investment promotion

The TWG consultant shall be selected and hired with honorarium, professional fees and allowances, under contract by the Municipal Mayor with authority of Sangguniang Bayan.

The TWG shall serve as the technical body that assist the Loon Coastal Geomorphic Conservation Tourism Park Management Council (LCGCTPMC) in all planning, project implementation and monitoring activities.

The TWG Functions and Responsibilities include the following:

- 1) To conduct research, studies and investigations.
- 2) To formulate and prepare technical proposals and projects for approval by the LCGCPMC, the Municipal Mayor and the Sangguniang Bayan.
- 3) To formulate technical guidelines and policies for approval by the LCGCTPMC, the Municipal Mayor and the Sangguniang Bayan.
- 4) To prepare or gather data and other documentary requirements on contracts and agreements to be entered into by the Local Government Unit of Loon and interested party/ies.
- 5) To conduct social preparation and Information Education Campaign (IEC) activities.
- 6) To conduct monitoring and evaluation activities.
- 7) To help to enforce the provisions of this ordinance.

SECTION 8. WORKING COMMITTEES.

There shall be created working committees as follows:

The terms of office of the working committee members shall be three (3) years or coterminus with the term of office of the Municipal Mayor whichever is longer.

SECTION 9. SECRETARIAT. There shall be created a Secretariat to be composed of personnel from executive department and legislative department duly designated by the Municipal Mayor. It shall take charge of records keeping, scheduling and coordinating of meetings and other activities.

SECTION 10. TERM OF OFFICE. The terms of office of the members of the Loon Coastal Geomorphic Conservation and Tourism Park Management Council, Technical Working Group and Secretariat shall be Three (3) years or co-terminus with the term of office of the Municipal Mayor, whichever is longer. (inserted new Sections 7-10)

SECTION 11. SOURCE OF FUNDS. The budget for the development and conservation of the Coastal Geomorphic Conservation and Tourism Park shall be charged to local funds including user's fee and other fees to be imposed. Other funding sources, like grants and public-private partnerships, shall be explored.

SECTION 12. PROHIBITED ACTS. The following acts are strictly prohibited on the uplifted intertidal zone:

12.a. Construction or installation of hazardous and /or pollutant industrial facilities, such as petroleum oil depot, high voltage electric, commercial scale piggery, poultry, embalming industry or other similar industrial facilities within the uplifted intertidal zone and extending up to 250 meters from its peripheral margin; any structures like multipurpose sheds and buildings, residential houses, and others that are not part of the development master plan for the area;

12.b. Collection or extraction of any materials or objects like sand, stones, pebbles, dead and broken corals, empty shells of marine organisms, and others that have ecological, geological or educational significance;

- 12.c. Cutting of trees especially in the mangrove areas as well as in the new-growth areas;
- 12.d. Unauthorized planting of mangroves or any species of trees on the uplifted coastal zones from the barangays of Napo, Lintuan, Basdacu, Pig-ot, Tangnan, Cuasi, Tontonan and Song-on; (amended Section 8d, Mun. Ord. No.14-003, Series of 2014)
 - 12.e. Unauthorized excavation for collection, construction or any other purpose;
 - 12.f. Dumping of garbage;
 - 12.g. Parking of motorized vehicles; and
- 12.h. Other acts that destroy or diminish the ecological, geological and educational significance of the area;
- **SECTION 13. REGULATION.** Activities and/or infrastructure, agricultural, fishery or other projects that entail the utilization of the conservation and tourism park are subject to the approval of the Loon Coastal Geomorphic Conservation and Tourism Park Management Council in conformity with other pertinent government laws and regulations.

SECTION 14. PENALTIES. Violation of this ordinance shall be fined as follows:

- a) First offense Five Hundred Pesos (P 500.00)
- b) Second offense One Thousand Pesos (P 1000.00)
- c) Third and succeeding offenses Two Thousand Five Pesos (P 2,500.00) (amended Section 10, Mun. Ord. No.14-003, Series of 2014)

SECTION 15. APPLICABILITY OF EXISTING LAWS. Whenever applicable, local and national laws on health, environment, tourism, trade and industry, and other related policies shall be enforced at the conservation and Tourism Park.

SECTION 16. REPEALING CLAUSE. Provisions of Municipal Ordinance No. 14-003 Series of 2014 which are inconsistent thereto, particularly in Section 3, Section 4, Section 8a,,d, Section 10, are hereby repealed or modified accordingly.
