MUNICIPAL ORDINANCE NO. 24-016

Series of 2024

AN ORDINANCE AMENDING SECTION 10 OF THE MUNICIPAL ORDINANCE NO. 24-004, SERIES OF 2024, ENTITLED: "AN ORDINANCE ESTABLISHING THE COLEGIO DE LOON, DEFINING ITS MANDATE AND APPROPRIATING FUNDS THEREFOR"

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as "An Ordinance Amending Section 10 of the Municipal Ordinance 24-004, Series of 2024, entitled: An Ordinance Establishing the Colegio de Loon, Defining its Mandate and Appropriating Funds Therefor".

SECTION 2. RATIONALE. The amendment of Section 10 of the Municipal Ordinance 24-004 is pursuant to CHED Memorandum Order No. 32 Series of 2006 and pursuant to Commission En Banc Resolution No. 868, Series of 2006.

SECTION 3. AMENDMENTS. Section 10 of the Municipal Ordinance 24-004 shall be amended to be read as follows:

SECTION 10. COMPENSATION.

- a. Creation of a Department. There shall be created a Department Office of Colegio de Loon in the Municipality of Loon. The creation of a Department of Colegio De Loon is mandatory and pursuant to CHED Memorandum Order No. 32 Series of 2006, entitled: "Policies Standards and Guidelines on the Establishment and Operation of Local Colleges and Universities" and pursuant to Commission en Banc Resolution No. 868, Series of 2006.

b. Staff Complement. There shall be staffing complement stated in Municipal Ordinance No. 24-008 to wit:

1. Municipal Government Department Head I (College Administrator), SG- 24
2. Registrar I, SG-11
3. Librarian I, SG-11
4. Guidance Counselor I, SG-11
5. Nurse I, SG-15
6. Instructor I, SG-12

c. The compensation of the college administrator and staff of the Colegio de Loon is subject to the subsequent compliance of the CHED requirements, and shall be compensated accordingly to pertinent compensation laws of the civil service commission.

SECTION 4. REPEALING CLAUSE. Any ordinance inconsistent thereto is hereby repealed and modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect upon its approval and compliance of the necessary requirements set by law.
