ORGANIZATION OF THE LUPONG TAGAPAMAYAPA INCENTIVES
AWARDS - MUNICIPAL AWARD COMMITTEE (LTIA - MAC)

WHEREAS, the Katarungang Pambarangay (KP) was created under Presidential Decree No. 1508, dated 11 June 1978, to formally organize into a system the time-honored Filipino tradition of amicably settling interpersonal disputes in a barangay without judicial recourse;

WHEREAS, the Lupong Tagapamayapa, herein referred to as Lupon, was empowered under the system to mediate, conciliate or arbitrate disputes in a barangay to promote the speedy administration of justice;

WHEREAS, the committed and dedicated performance of the Lurons has brought the success of the Katarungang Pambarangay for years;

WHEREAS, in recognition of the Lurons' contributions in the promotion of the Katarungang Pambarangay objectives, Section 406b of the Local Government Code of 1991 (Republic Act 7160) mandates the Department of the Interior and Local Government to grant economic or other incentives to outstanding Lurons;

WHEREAS, as mandated in DILG Memorandum Circular No. 2008-102 dated June 17, 2008 and 2016-58 dated April 29, 2016, the City/Municipal Award Committee (C/MAC) shall be organized to evaluate the Lupong Tagapamayapa of all barangays within the city or municipality.

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Organization of the Lupong Tagapamayapa Incentives Awards - Municipal Award Committee (LTIA-MAC). - The LTIA-MAC of Loon, Bohol is hereby organized and constituted as follows:

Section 2. Functions of the LTIA-MAC. - The Committee shall perform the following functions:

- a. Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in Loon;
- b. Disseminate information on the awards to generate awareness and support from the public and private sectors within the municipality;
- c. Select and submit to the Provincial Awards Committee (PAC) the best performing lupon within the municipality;
- d. Secure, whenever necessary, counterpart funds from the partner agencies and the private sector; and
- e. Plan and implement appropriate awarding ceremonies.

Section 3. Technical and Secretariat Support. - The Municipal Local Government Operations Office (MLGOO) shall provide technical and secretariat services to the Committee.

Section 4. Schedule of the Search. - The schedule of the municipal search shall be based on the timelines set by the DILG.

Section 5. Funding Support. - The LGU of Loon may provide mobility funds and cash awards to the winners at the municipality level.

Section 6. Effectivity. - This Executive Order shall take effect immediately and shall remain in force until expressly revoked.
