CONSTITUTING THE LUPONG TAGAPAMAYAPA INCENTIVES AWARDS  
MUNICIPAL AWARD COMMITTEE (LTIA - MAC)

WHEREAS, the Katarungang Pambarangay was created under Presidential Decree No. 1508, dated 11 June 1978, to formally organize into a system the time-honored Filipino tradition of amicably settling interpersonal disputes in a barangay without judicial recourse;

WHEREAS, the Lupong Tagapamayapa, hereinafter referred to as Lupon or Lurons, was empowered under the system to mediate, conciliate and arbitrate disputes in a barangay to promote the speedy administration of justice;

WHEREAS, the committed and dedicated performance of the Lurons has brought success to the Katarungang Pambarangay for years;

WHEREAS, in recognition of the Lurons' contributions to the promotion of the Katarungang Pambarangay objectives, Section 406b of the Local Government Code of 1991 (Republic Act No. 7160) mandates the Department of the Interior and Local Government to grant economic or other incentives to outstanding Lurons;

WHEREAS, in view of the foregoing, there is a need to organize a Lupong Tagapamayapa Incentives Awards Municipal Award Committee to evaluate the Lurons of all barangays within Loon in compliance with DILG Memorandum Circulars No. 2008-102 dated June 17, 2008 and No. 2016-58 dated April 29, 2016;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

**Section 1. Organization of Lupong Tagapamayapa Incentives Awards - Municipal Award Committee (LTIA-MAC).** - The LTIA-MAC of the Municipality of Loon is hereby organized and constituted as follows:

**Section 2. Functions of the LTIA-MAC.** - The Lupong Tagapamayapa Incentives Awards - Municipal Award Committee (LTIA-MAC) shall perform the following functions:

- 2a. Initiate and coordinate the activities that lead to the successful implementation of the LTIA;
- 2b. Disseminate information on the Awards to generate awareness and support from the public and private sectors;
- 2c. Select and submit to the Provincial Awards Committee (PAC) the best performing lupons within the Municipality of Loon;
- 2d. May secure counterpart funds from the partner agencies and the private sector; and
- 2e. May plan and implement appropriate awarding ceremonies.

**Section 3. Technical and Secretariat Support.** - The DILG Municipal Local Government Operations Office shall provide technical and secretariat services to the Committee.

**Section 4. Schedule of the Search.** - The schedule of the municipal search shall be based on the timelines set by the DILG.

**Section 5. Funding Support.** - The LGU of Loon may provide mobility fund and cash award to the winners at the municipality level.

**Section 6. Effectivity.** - This Executive Order shall take effect immediately.
